30 years of Research on European Matters

The Greek Centre of European Studies and Research (EKEME in its Greek acronym) was founded in 1980 by a group of academics, legal practitioners, economists and social scientists.

EKEME was founded and operates as a non-profit institution, independent of any political or State affiliation. It does not benefit of any regular subsidy, but is been financed by its members and through participation to programs and initiatives sponsored by national and EU sources. EKEME has worked to shed light on several aspects of Greece's membership to the EC/EU and to the integration process, with facts, with studies, with research programs and through participation to transnational research ventures. EKEME is the Greek member of the Trans-European Policy Studies Association (TEPSA).

EKEME brings together the research experience and analytical capacity of a wide range of disciplines, especially economics, law, political science, sociology, as well as european and international relations. It has participated and is presently engaged in multi-disciplinary research programmes that allow for policy proposals in fields of current interest for Greece's membership to the EU and European integration at large.

The board of EKEME consists of the President, Advocate Mr. N. Frangakis, the Vice-President, Professor Emeritus A. A. Xenophon Yataganas, former Legal Advisor, European Commission is Director of Research and Nikolaos Lymouris, Dr. of Political Sciences, is the Executive Secretary of EKEME. About 30 more

distinguished personalities are EKEME's associates.

Since the end of 2010 a Group of research fellows is created in EKEME. At the moment this group consists of 19 members and its number is growing. This group of young researchers will bring a new impetus inside the organisation through working papers and research programmes.

In May 2011, EKEME has co-organised with TEPSA and ECEFIL a conference on the topic: **“After the Crisis: Adjustment in Greece and the Eurozone”** in Brussels at the EP building with the support of its many Greek MEPs. News from the EXACT project



EXACT event at the Finnish Institute of International Affairs 7-8 September 2011

On 7 September EXACT Marie Curie researchers Marlene Gottwald, Vanessa Boas, Leonhard den Hertog, Marco Siddi, Niklas Helwig, Andrew Byrne and James Nyomakwa-Obimpeh participated in the EXACT Ph.D. workshop “The EU and its neighbourhood – current challenges and conflicts”, which took place at the Finnish Institute of International Affairs (FIIA).

The event started with a welcome speech by FIIA Director Teija Tiilikainen and the introductory presentation of Jukka Salovaara, Director General of the Department of Europe in the Finnish Ministry for Foreign Affairs. Mr. Salovaara presentation focused on domestic and foreign aspects of Finland’s EU policy and was commented by Mr. Juha Jokela, FIIA Programme Director of the EU Research Programme.

In the first session of EXACT presentations, Marco Siddi and Vanessa Boas analysed the Eastern dimension of the EU’s neighbourhood. Marco Siddi presented the paper “Bystander in its neighbourhood? The European Union’s involvement in protracted conflicts in the post-Soviet space”, while Vanessa Boas’ paper focused on “Civil unrest in Europe’s last dictatorship: a window of opportunity for EU-Belarus relations?”

During the second round of presentations, Leonhard den Hertog and Niklas Helwig analysed the Southern dimension of the EU’s neighbourhood. Leonhard den Hertog’s presented a paper titled “Revolution and war on Europe’s doorstep: Migratory movements from North Africa and implications for the EU’s common immigration policy”, while Niklas Helwig’s paper focused on “Leadership in CFSP – Potential and performance of the High Representative in the immediate reaction to the crises in Egypt and Libya”.

The workshop sessions were chaired by FIIA researchers and also attended by other Ph.D. students from Finnish Universities.

On 8 September the EXACT researchers attended Andrew Moravcsik’s lecture at the University of Helsinki, which took place on the occasion of the European Studies Day. After the lecture, the EXACT fellows had a guided tour of the Finnish parliament.

The success of the EXACT event at Helsinki was ensured by the excellent organizational work done by Marlene Gottwald, the EXACT researcher currently based at FIIA, and the kind hospitality of Mr. Juha Jokela, who accompanied the EXACT fellows for the whole duration of the event.

Recent Events

University of Ljubljana and TEPSA Workshop on the Impact of the Crisis on Regional Economic and Financial Integration in Asia and Europe 14-16 September 2011

The global financial and economic crisis represent an unprecedented challenge to the Asia-Europe Meeting (ASEM) community. In this context Asia and Europe have much to share.

The University of Ljubljana together with Asia-Europe Foundation, Asian Development Bank Institute, Prospex and Europe-Asia Policy Forum organized a workshop in the city of Ljubljana from the 14th to the 16th of September 2011.

Involving high level experts from both regions notably the keynote address of *H.E Samuel Zbogar*, Minister for Foreign Affairs, Slovenia, the workshop aimed at generating innovative ideas and informed recommendations on how to prepare for future crises, identifying vulnerabilities and activities for more extensive cooperation. It also shared Asian and European experience in regional financial cooperation with the objective to foster global integration.

The workshop specifically discussed issues related to future monetary regimes, regional financial integration mechanisms, regulatory frameworks, fiscal policy implications, as well as capacity-building activities.

TEPSA training – EXACT Network Seminar on Professional Skills 6-19 October 2011

The TEPSA EXACT Training took place in Brussels, at the Fondation Universitaire.

This TEPSA seminar was a special training programme for a small group of researchers in an early stage of their career in research and policy advice. The edition of 2011 was organised in the framework of the EXACT Marie Curie Initial Training Network project, in which 12 researchers on EU external action take part.

Another eight external early stage researchers had also been selected to participate in this 14-day training.

Dr. Hanna Ojanen was Scientific Director of the Training Seminar.

An intense and outstanding programme with various high-level speakers was prepared for these 14-day training and consisted of the development of practical skills on advice, assessment, analysis, administration of project and research financing, including career development).

THESEUS Conference Which way forward? Three Years after Lehman, Two Years after Lisbon

24-25 November 2011

This year's THESEUS conference will discuss present challenges and future perspectives of the EU two years after the Lisbon Treaty has come into force.

Therefore, pressing questions and core issues will be discussed with a special focus on the German perspective. How can Europe's economic future be shaped? Which role and obligation does the Franco-German couple assume? Does leadership mean active search for European compromises or simply crisis management in European affairs?

Moreover, the Lisbon Treaty introduces profound institutional innovations. The conference will try to assess the impact on the institutional landscape. Particularly with regard to EU external action the conference will discuss if the innovations and substantive changes stand the test of time.

In the evening of 24 November 2011 THESEUS will remit the Awards for Outstanding and Promising Research on European Integration 2011. This year's THESEUS Award for Outstanding Research will be given to Prof. Dr. Beate Kohler Koch from the University Mannheim. She has been selected for her outstanding academic record in the field of European integration research. The first award winner, Prof.

Dr. Helen Wallace (London School of Economics) will also attend the conference.

Susann Heinecke, political scientist, joins the Centre de formation européenne (CIFE) and the Institut européen des hautes études internationales (IEHEI) as its research associate in Berlin. She coordinates the Berlin trimesters of IEHEI's Master

programmes in Advanced European and International Studies, after having worked in the state chancellery of Brandenburg and in several universities (Leipzig, Moscow, St. Petersburg). In her research and lectures, she focuses on foreign policy analysis, German foreign policy and German-Russian relations, as well as on theories of international relations, the developments in

Eastern Europe and the EU's relations with Eastern European countries. In 2011, she did her doctorate on Germany's Russia policy.

Awards

Patrick Le Galès elected member of the prestigious British Academy. Patrick Le Galès, CNRS Director of Research at Sciences Po's Centre d'Etudes Européennes and professor at Sciences Po has been elected a Corresponding Fellow of the Political Science section of the British Academy. He is the first French to be elected as member of the Political Science section. Founded in 1902, the British Academy is the humanities/social sciences counterpart of the Royal Society (which is devoted to the "hard" sciences). The election of Patrick Le Galès will cement the international recognition of his work.

A graduate of Sciences Po, Nuffield College Oxford and the Université de Paris X Nanterre, Patrick Le Galès is a political scientist and sociologist. He was awarded the CNRS Bronze Medal in 1996, the Stein Rokkan Prize for Comparative Social Science Research in 2002 by the International Social Science Council and the 2007 Prize for Excellence in Social Science Research by the Fondation Mattei Dogan/Association Française de Science Politique.

His comparative research centres mainly on questions of governance, public action, the restructuring of the state (especially in Great Britain), and the detransformation of cities, European regions and large cities worldwide. At Sciences Po he has created and co-directed the Master in Regional and Urban Strategies, the double Master between Sciences Po and the London School of Economics "Urban policy" and "Governing the large metropolis" as well as the Master of Public Affairs. He is co-director of two of Sciences Po's priority research programs, "Cities are back in town" and "Réseau Etat Recomposé." <http://www.sciencespo.fr/en/content/7612/patrick-le-gal%C3%A8s>

Awards recently given to young doctors from the Centre d'études européennes of Sciences Po:

Virginie Van Ingelgom received the Prix de thèse Jean Blondel awarded by the European Consortium for Political Research. This 1000 Euro prize is also accompanied by an offer to translate her thesis into English and have it published by the ECPR Press.

Her thesis on "Intégrer l'indifférence: une approche comparative, qualitative et quantitative, de la légitimité de l'intégration européenne", which she defended under the joint supervision of the Université catholique de Louvain and Sciences Po in May 2010, also received the Prix de thèse de la

Fondation Mattei Dogan en politique comparée awarded by the AFSP and the Award for Promising Research on European Research on European Integration du réseau THESEUS.

Virginie is chargée de recherche F.R.S.-FNRS at the Institut de Sciences Politiques Louvain-Europe. She received a scholarship from the Research in Paris program of the City of Paris to study public attitudes towards European integration. She will undertake this research project at the CEE for a period of six months.

Claire Dupuy received the Prix de thèse de la Fondation Mattei Dogan dans la catégorie politiques publiques. Her thesis, which she defended in 2010 under the joint supervision of the University of Milan-Bicocca and Sciences Po, is entitled "Politiques publiques, territoires et inégalités. Les politiques régionales d'éducation en France et en Allemagne (1969-2004)".

Now a Post-doctoral Fellow at the Centre d'études et de recherches internationales of the Université de Montréal in 2010-2011, Claire will be Deakin Visiting Fellow 2011-2012 at Oxford University (St. Antony's College).

Aurélien Evrard received the Prix JCPA-AFSP du meilleur texte comparatif « jeune chercheur » during the XIth symposium of the Association française de science politique.

Aurélien defended his thesis, « L'intégration des énergies renouvelables aux politiques publiques de l'électricité en Europe. Une comparaison : Allemagne, Danemark, France » in December 2010. He is currently maître de conférence in political science at the Université Paris 3.

Research projects

The **Finnish Foreign Policy** project seeks to support foreign policy research in Finland and to arouse international interest in the topic. The online archive, which consists of speeches and key foreign policy documents and sits at the heart of the project, will be launched in 2011.

Another function of the project is to build a network of interested researchers by organising research seminars on Finnish foreign policy and the ultimate aim of the project is to stimulate

publications in the field. To that end, the Institute has launched a new publication series: Finnish Foreign Policy Papers.

The first paper in the series is written by Eric Hayes, the former Head of the European Commission Delegation in Finland, and is titled *From Cold War to Common Currency: A personal perspective on Finland and the EU*.

The aim of the Institute's recently launched peace mediation project is to enhance debate, research and awareness of peace mediation in Finland by bringing together national and international researchers, experts and decision-makers.

The project, which is conducted in close cooperation with the Crisis Management Initiative (CMI), draws upon networks of researchers and practitioners in order to organise events and training as well as to analyse the key questions relating to Finnish peace mediation capacity and tradition, the topical issues of peace mediation, peace mediation as part of Finnish foreign policy, and the role of small states in peace mediation.

FIIA has been commissioned to undertake research for the European Parliament regarding the **EU's foreign policy towards the BRICS** in a joint project with the College of Europe.

The final report of the **PROBALT** project, which aims to make the prevention of the Baltic Sea eutrophication more effective, will be published in November.

New researchers

Dr Bart Gaens and Ambassador Eija Rotinen have joined the Global Security programme. Dr Gaens is an expert on Japan and EU-Asia relations and will be focusing on major power relations in Asia. Ambassador Rotinen, who is a Visiting Researcher from the Ministry for Foreign Affairs, has a great deal of experience in the Middle East, North Africa and Latin America. Furthermore, Jyrki Kallio will join the programme in October and will focus on Chinese political thinking and Chinese foreign policy.

In November, Dr Hanna Ojanen will return from the Swedish Institute of International Affairs (UI) to the FIIA EU research programme and Niklas Helwig will join the programme as an EXACT fellow.

Institut für Europäische Politik e.V.
Expert workshop on the long term economic perspectives of the Euro zone
20 July 2011



The Institut für Europäische Politik e.V. in cooperation with the Policy Planning Unit of the Federal Foreign Office organised an expert workshop on the long term economic perspectives of the Euro zone on the 20th of July 2011. In the workshop titled „Jenseits des Schuldenberges – Konvergenz oder Divergenz im Euro-Raum?“ (“Beyond the mountain of debt – convergence or divergence in the euro area?”) officials from the federal ministries and researchers discussed the development of economic divergences within the Euro zone and their role in the root causes of the current sovereign debt crisis. This analysis served as a starting point for discussing the long term governance of the Euro zone, also drawing on experience from other large currency areas. The interdisciplinary seminar focused on both, the economic pros and cons of different governance

options as well as the political and legal sides of their implementation.

This year, the Institute for International Relations (IMO) has organized the 6th bilateral conference in a row with its partners from Japan: University of Tokyo, Kobe, Doshisha and Kyoto. Subject of this year’s conference: “Borders around the Globe: Psychological, Territorial and Digital Aspects” has gathered many young scholars and researchers who presented their views of borders from various scientific fields. Conference lasted two days and it consisted of four sessions focusing on the border issues from the perspective of political science, sociology, economics and environmental protection.

This bilateral cooperation is distinguished by its multidisciplinary nature that encompasses various scientific themes as it gathers scientists of a different expertise to discuss the same subject from the different perspective. The conference proceedings will be published in an almanac that will contain all the lectures from the European tour of Japanese scientists (Vienna, Belgrade, Subotica, Hague, Zagreb, etc). European tour designates the series of bilateral conferences around the Europe that Japanese scientists have embosomed in their three weeks sojourn at the continent. Next year, the 7th bilateral Croatia and Japan conference is planned to be held at IMO in the Fall 2012.

The European Union must take a decisive step towards a federal economic government, with common fiscal policies and a larger budget, if it is to save the euro. Saving the euro is the precondition for the economic recovery of all Europe. A major revision of the EU treaties can no longer be avoided.

In Federal Union Now Duff argues that the current negotiations on the reform of the EU's finances must aim to transfer items from the states' budgets to the EU budget in the interests of efficiency savings. Such a shift in the levels of spending must be accompanied by the creation of independent streams of revenue to the EU.

The 'economic governance' proposals of the German and French leaders are inadequate and counterproductive. Instead, federal solutions must be found to secure the future of European integration. This new form of EU federal government will require the creation of an EU treasury and the integration of the presidencies of the European Commission and European Council. As a contingency plan, Duff proposes that a new category of associate membership be created to cater for the likelihood that the UK will decide not to follow, at least for now, the federalist integration of its mainland European partners.

Open Consultations of the European Commission

TEPSA would like to draw your attention to the following open consultation.

The Direction General for Research and Innovation published a Consultation on the ERA Framework: Areas of untapped potential for the development of the European Research Area (ERA).

This public consultation aims at gathering views and evidence from stakeholders on the key obstacles which have to be tackled to achieve a well-functioning ERA.

Completing ERA will require the support and effort of all EU Member States and Associated Countries and their stakeholders (e.g. research performing organisations including universities, funding organisations, researchers, private sector and civil society).

The Heads of State and Government of the European Union have called to address remaining

gaps for the achievement of the European Research Area rapidly in order to complete the ERA by 2014 to create a genuine single market for knowledge, research and innovation. The consultation aims to reinforce the Commission analysis of the key issues to be addressed as well as to gather views on their importance: researchers' careers and mobility, research infrastructures, cross-border operation of research actors, knowledge circulation, International cooperation and cross-cutting governance issues.

The outcome of the consultation will help the Commission to decide on those issues, which should be addressed as priorities when preparing by 2012 the ERA Framework, which will set out the focused, proportionate and effective measures to be taken to realize ERA.

The period of consultation will last from 13.09.2011 to 30.11.2011.
